NOTIFICATION
Senapati, the 23rd Sept, 2013.

No.4/6/2013-DSO/CAF&PD/SPT: In pursuance of the Sectt: CAF&PD, Govt. of Manipur notification no. 6/17/2013-CAF&PD dated the 30 Aug,2013, the National Food Security Ordinance,2013 envisages to provide food grains at subsidized rate to the eligible households of the State. The eligible households have been classified as (i) Antoyodaya Anna Yojana Household and (ii) Priority Households.

The eldest female will be treated as head of Household. Applicants will be assisted in filling up the forms in the office of Deputy Commissioner. The application should be submitted in the prescribed format by the head of household enclosing the following documents:

- I. Residence proof of the applicant.
- II. Income Certificate issued by the Revenue Deptt.
- III. Ration Card (if the applicant or any member of the household has ration card of any type.
- IV. An Undertaking by the applicant duly attested by an Executive Magistrate in the prescribed format that the applicant does not fall under any of the exclusion categories.

Inclusion Criteria:

The household having annual income less than Rs.1.00 lakh and fulfilling the following criteria will be considered as eligible households for inclusion in the AAY and Priority category as the case may be:

- i. Households with disable person (as defined in persons with Disabilities Act, 1995) subject to submission of prescribed medical certificate.
- ii. Single women (including Widows, Unmarried and Separated and deserted women) living in household as dependent or as head of household.
- iii. Children living without protection
- iv. Person living with HIV/AIDS.
- v. Occupationally vulnerable groups like unskilled construction workers, casually daily wages labour Casual domestic workers, cycle rickshaw drivers, unskilled workers in small households enterprises unskilled workers in household industries.
- vi. Any other households having annual income of less than Rs. 1.00 lakh per annum.

Exclusion Criteria:

Notwithstanding their fulfilling the inclusion criteria, the following households will not be eligible:

- i. If any member of the household owns a light (Four Wheeler) or heavy vehicle.
- ii. If the household is receiving ration/food subsidy under any other scheme.
- iii. If any member of the household is income Tax payee.

Under this notification, all village Authorities are informed to submit the details through the concerned Sub-Divisional Officer or to the Deputy Commissioner, Senapati or to the District Supply Officer (CAF&PD), Senapati on or before 3rd of Oct, 2013 without fail. Failing which no further complaint shall be entertained.

The application form shall be available free of cost in the office of the DSO (CAF&PD), Senapati.
